

MINUTES OF REGULAR MEETING BOARD OF PARK COMMISSIONERS July 8, 2019

STUDY SESSION: JMAC PUBLIC LAND STUDY & DATABASE

Joe Brady commented that members of JMAC recently were presented with the final Forterra land study results. Mr. Brady noted that in 2018 Forterra partnered with members of the Joint Municipal Action Committee (JMAC), a group of local government agencies and nonprofits, to design a community asset map of the City of Tacoma. The purpose of this map is to give JMAC members a tool to inform real estate decisions that result in multiple public benefits. By combining a range of shared priorities around land use in evaluating opportunities for acquiring or activating public property, the map provides a lens through which to assess where investments can achieve the broadest public good.

Mr. Brady then gave a brief demonstration of the GIS mapping tool/database. He commented on the usefulness of this tool as the District takes on projects such as the level of service study and the school yard parks exploration.

RECOGNITION OF SIGMA GAMMA RHO

Marina Becker and Jan Bretana introduced representatives from Sigma Gamma Rho. Ms. Bretana spoke of the sorority's partnership with USA Swimming to support water safety in the community. A video highlighting the recent Summer Splash event held in June at Stewart Heights Pool was viewed. The Board and staff thanked Sigma Gamm Rho members for their coordination of the event that had over 400 attendees.

Executive Director, Shon Sylvia commented on the following:

- Joint Study Session with City Council is tomorrow July 9th at noon.
- Last week the District received a congratulatory letter from TripAdvisor informing us that we have been awarded a certificate of Excellence for Point Defiance Park for the 5th consecutive year of high ratings from travelers to Tacoma.
- Saturday was a spectacular day for Metro Parks and Tacoma with the opening of Wilson Way and Dune Peninsula.
- The District is hosting the sixth annual Metro Parks Food Truck Fest on Sunday, July 21, 2019 in Wright Park.
- District Park Rangers hosted our first-ever Junior Ranger Kickoff event on June 26th and welcomed 33 participants.
- Blueberries and Blues, a sweet summer celebration Sunday, July 14th, 4-7 pm at Charlotte's Blueberry Park. The event will start with a ribbon of the new playground equipment made possible through a partnership with the Trust for Public Land.

Final Acceptance for construction of play equipment by Trust for Public Lands

EXECUTIVE SUMMARY: This resolution approves the acceptance of construction and installation of play equipment in the amount of \$107,077.00 by the Trust for Public Land (TPL)/ Kaiser Permanent in Charlotte's Blueberry Park.

BACKGROUND: The Trust for Public Land is a national nonprofit organization that partners with community organizations and individuals for the purpose of planning and creating parks and opens paces that contribute to healthy, livable communities. TPL receives grants from Kaiser Permanente and facilitates the use within the community. Charlotte's Blueberry Park was chosen for its health-focused activation to compliment the new community garden and the existing blueberries.

TPL worked with MPT staff to lead a Participatory Design Process for multiple community engagements for input and feedback to meet the neighborhood's desires. This project involved community outreach, design, procurement, construction and construction administration from TPL. The project provided new play equipment and fall material valued at \$107,011.00.

A Memorandum of Understanding outlined the parties' respective roles and responsibilities for the project. MPT has full ownership and maintenance once accepted. Staff and TPL provided at punchlist and all items are complete and to MPT satisfaction.

FISCAL IMPACT: The Trust for Public Lands provided all the related design and construction services for this project. The total value of this improvement was \$107,077.00.

BACKGROUND: Under the Regence Blue Shield brand, Cambia Health Solutions is providing financial support for the Metro Parks mobile teaching kitchen concession trailer. Programming of the mobile teaching kitchen will allow Metro Parks to offer foundational cooking skills and help bridge the gap from food desert to healthy eating throughout our community. Metro Park's staff continues to foster our relationship with Cambia Health Solutions to identify projects that will make a positive impact in our community.

Staff advertised Request for Proposal (R2019-10) on April 22, 2019 with the bid due date being May 13, 2019. Only one bid was received and the bid was too costly and therefore rejected. Staff updated the bid docs and advertised again with RFP#: 2019-11consistent with policy on May 16, 2019 and received one response that was considered non-responsive. We then contacted Concession Nation Inc. and requested a quote for a mobile teaching kitchen that would meet the specific needs we were seeking.

FISCAL IMPACT: Funds will come from a sponsorship from Cambia Health Solutions.

EXECUTIVE SUMMARY: This resolution authorizes contract Change Order No. 28 to Guy F. Atkinson, LLC for the Point Defiance Park Waterfront Phase 1 Project-Trail and Bridge & Peninsula, in the amount not to exceed \$5,167,814.26, bringing the contract total to an amount not to exceed \$62,310,235.74 (inclusive of Washington State sales tax).

<u>CAPITAL IMPROVEMENT COMMITTEE RECOMMENDATION:</u> This resolution was reviewed by the Capital Improvement Committee at their meeting on Wednesday, July 10, 2019 and was accepted for forwarding on to the full Board with a recommendation for approval.

BACKGROUND: Metro Parks continues to advance the improvements to the Point Defiance Park Waterfront Phase I project that includes the Trail & Bridge, Boat Trailer Parking, Park on the Peninsula, Roundabout and all associated utility and site improvements. Point Defiance Park Waterfront Phase I includes a complex set of sub-projects including capping of a contaminated site that will continue to be used for public park purposes. This project reached substantial completion on June 24, 2019.

Work under this Change Order generally includes additional project costs attributed to:

Repair of native ground water seeps, peninsula drainage revisions, fencing revisions, and additional funding associated with the soil treatment, soils handling and other issues including contractor's time delay claim for design changes requested by, and other requirements imposed by, the United States Environmental Protection Agency.

WHEREAS, after further negotiations with the contractor, the final amount of Change Order No. 3 was issued for \$14,243,592.69 for a total contract amount of \$14,649,285.28 leaving a remaining authorized amount of \$7,184,228.18; and

WHEREAS, using the remaining authorized amount, Staff further negotiated additional work necessary to move the project forward and issued Change Order No. 4 for \$6,983,889.00 for a final Early Work Package/Earthmoving amount of \$21,227,481.69 for a total contract amount of \$21,633,174.28; and

WHEREAS, the Board of Park Commissioners of the Metropolitan Park District of Tacoma approved Change Order No. 5 for up to an amount \$26,935,000(including tax) for Trail & Bridge work, armoring and completion of earthwork services on August 22, 2016 by Resolution# PW78-16; and

WHEREAS, the Board of Park Commissioners of the Metropolitan Park District of Tacoma approved Change Order No. 6 for up to an amount of \$261,599.84(including tax) for additional work on the Peninsula per EPA requests and reimbursed by EPA, on January 23, 2017 by resolution PW7-17; and

WHEREAS, the Board of Park Commissioners of the Metropolitan Park District of Tacoma approved Change Order No. 7 for an amount not to exceed \$312,810.79(including tax) for additional work on the Peninsula and reimbursed by EPA and The Tacoma Yacht Club, on March 27, 2017 by Resolution No.PW27-17; and

WHEREAS, the Board of Park Commissioners of the Metropolitan Park District of Tacoma approved Change Order No. 8 for an amount not to exceed \$1,413,953.73(including tax) for additional work on the Peninsula and reimbursed by EPA, on April 24, 2017 by Resolution No.PW36-17; and

WHEREAS, the Board of Park Commissioners of the Metropolitan Park District of Tacoma approved Change Order No. 9 for Guy F. Atkinson Construction, LLC for an amount not to exceed \$462,483.60 (including tax) for additional work on the Peninsula and reimbursed by EPA on June 12, 2017 by Resolution No. PW50-17; and

WHEREAS, the Board of Park Commissioners of the Metropolitan Park District of Tacoma approved Change Order No. 10 for Guy F. Atkinson Construction, LLC for an amount not to exceed \$3,600,000 (including tax) to be partially reimbursed by WSDOT on June 26, 2017 by Resolution No. PW58-17; and

WHEREAS, Change Order No. 10 was never executed, as Guy F. Atkinson Construction, LLC subsequently withdrew their proposal for the Roundabout Construction prior to formal contract amendment for the execution of work described under Resolution No. PW58-17; and

WHEREAS, the Board of Park Commissioners of the Metropolitan Park District of Tacoma approved Change Order No. 11 for Guy F. Atkinson Construction, LLC for an amount not to exceed \$1,153,688.64 (including tax) to be reimbursed by EPA on July 10, 2017 by Resolution No. PW62-17; and

WHEREAS, the Board of Park Commissioners of the Metropolitan Park District of Tacoma approved Change Order No. 12 for Guy F. Atkinson Construction, LLC for an amount not to exceed \$814,837.69 to be reimbursed by EPA and the Tacoma Yacht Club on August 14, 2017 by Resolution No. PW72-17; and

WHEREAS, Change Order No. 13 for Guy F Construction, LLC was a no cost change order to implement Davis Bacon Language; and

WHEREAS, the Board of Park Commissioners of the Metropolitan Park District of Tacoma approved Change Order No. 14 for Guy F. Atkinson Construction, LLC for an amount not to exceed \$714,994.31, but was executed for \$708,926.61, to be reimbursed by EPA and the Tacoma Yacht Club on October 23, 2017 by Resolution No. PW89-17; and

WHEREAS, the Board of Park Commissioners of the Metropolitan Park District of Tacoma approved Change Order No. 15 for Guy F. Atkinson Construction, LLC for an amount not to exceed \$400,000, to increase owner's contingency on December 11, 2017 by Resolution No. PW105-17; and

WHEREAS, the Board of Park Commissioners of the Metropolitan Park District of Tacoma approved Change Order No. 16 & 17 for Guy F. Atkinson Construction, LLC for an amount not to exceed \$228,518.58, to be reimbursed by EPA and the Tacoma Yacht Club, by Resolution No. PW22-18; and

WHEREAS, the Board of Park Commissioners of the Metropolitan Park District of Tacoma approved Change Order No. 18 for Guy F. Atkinson Construction, LLC for an amount not to exceed \$163,019.62, to be reimbursed by EPA, by Resolution No. PW47-18; and

WHEREAS, the Board of Park Commissioners of the Metropolitan Park District of Tacoma approved Change Order No. 19 for Guy F. Atkinson Construction, LLC for an amount not to exceed \$365,900.06, to be reimbursed by EPA, by Resolution No. PW70-18; and

WHEREAS, the staff negotiated with the contractor and the Executive Director of the Metropolitan Park District of Tacoma approved Change Order No. 20 for Guy F. Atkinson Construction, LLC for an amount not to exceed \$355,642.64, to be reimbursed by EPA; and

WHEREAS, Change Order No. 21 for Guy F. Atkinson Construction, LLC was a no cost change order to implement tax and allocation corrections; and

WHEREAS, the staff negotiated with the contractor and the Executive Director of the Metropolitan Park District of Tacoma approved Change Order No. 22 for Guy F. Atkinson Construction, LLC for an amount not to exceed \$745,102.67; and
